

2 About this Product

2.1 Introduction to the ALEXA 35

For over a decade the combination of the ALEV 3 sensor and ARRI Color Science have set the gold standard for digital image quality in the professional motion picture industry with ALEXA and AMIRA cameras.

Now, with the introduction of the ALEXA 35 camera, ARRI raises the bar even higher with the new Super 35 format 4.6K 3:2 ALEV 4 sensor and new REVEAL Color Science. ALEXA 35 provides significantly more exposure latitude, improved color reproduction, better look handling and increased creative control for the cinematographer, while fulfilling the 4K mandate for all Super 35 and LF lenses, spherical and anamorphic. With its familiar controls and a new line of custom crafted accessories, ALEXA 35 is the most versatile Super 35 motion picture camera available.

- Up to 120 fps



- At ambient temperatures above 25° C (77° F), protect the camera and camera accessories from direct sunlight.

A CAUTION



Hot Surfaces on Recording Media

During extended operation, high data rates and/or operation at high ambient temperatures, the recording media in the camera can get hot to the touch and can cause pain or even burns if held for too long directly after removal.

- ▶ Do not handle the recording media for longer than three seconds and remove it quickly but carefully.
- Consider to wear protective gloves when removing the recording media or allow it to cool down beforehand.
- ▶ Do not put any labels or adhesive tape on the recording media (especially the side facing the camera body). The recording media must have full contact to the thermal surface to ensure proper heat conduction.

Rotating Lens Motor

Risk of crushing fingers and capturing and unraveling long hair, jewelry and/or clothing.

- ▶ Make sure that the lens motor is properly attached to the lens.

ADVICE



Open Lens Mount

When no lens or lens cap is attached to the camera, dirt and dust particles may enter the camera and settle on the sensor cover glass. Particles on the sensor cover glass can later be visible in the recordings made by the camera.

- Place the protective cap on the lens mount, when no lens is attached to the camera
- Contact ARRI Service to inspect the camera if undefined spots appear in the image.


Connection of Onboard Monitor

Damage to the SDI driver chip caused by power surge.

- Always make sure to plug in the power cable first and then connect the BNC cable. As soon as the power and BNC cables are connected, you can switch the camera or the accessories on or off.
- ▶ Always make sure to disconnect the BNC cable first and then disconnect the power cable.
- Only use shielded power cables to power accessories that connect to the camera with a BNC cable. When only the plus pin connects on a shielded power cable, the shield will act as the power return and therefore not damage the SDI output.






Improper Mounting of Lenses and Accessories

Mounting the camera on tripods or other support equipment and attachment of accessories like e.g. lenses, electronic and mechanical accessories poses a crushing hazard for fingers and/or hands.




Bottom Attachment Points

5.2 Power Supply

ADVICE




Improper handling of cables

Risk of damage to the camera system.

- ▶ Operate the system using only the type of power source indicated in this document.
- ▶ Always unplug the power cable by gripping the power plug, not the cable.
- Do not supply power outside the specified voltage range.
- ▶ Always keep the PWR connector accessible so that the cable can be unplugged quickly in case of emergency.
- Do not use power cables longer than 4m.
- Always properly secure cables connected to the camera to avoid pinching or tripping.

The camera accepts an input voltage range from 20.5 to 33.6 V DC and can be powered through the PWR connector or through the BAT interface on the camera rear using a battery adapter and a suitable onboard battery.

Power In (PWR) Connector



The PWR 8-pin LEMO connector (1) is located at the right side of the camera. Use KC50-S (K2.75007.0) or KC50-SP-S (K2.0001275) power cables to connect the camera to a power supply.

ADVICE




Improper Handling of Batteries

Risk of damage to the camera system.

- ▶ Use only batteries with a capacity of 86 Wh or more to prevent damage to the battery and unpredictable camera behavior. Any camera-battery combination should be tested prior to use, especially when accessories are powered through the camera.
- ▶ Use only batteries providing a current of at least 12 A for a camera setup without any accessories. When using accessories like motors or monitors, choose batteries with higher current according to the power draw of the accessories.
- Battery adapters must be installed by trained personnel.

The camera can be equipped with different battery adapters, e.g.

- B-Mount Battery Adapter (K2.0023751)
 to use B-Mount batteries in 7s or 8s configuration (respectively 25.2 V and 28.8 V nominally).
- Battery Adapter Back BAB-LF (K2.0034204)
 to use any 24 V or 26 V power solution that can attach to the ALEXA LF back



The battery adapters attach to the recessed area at the back of the camera with four captive M4 screws.

Use a 3.0 mm Allen/hex key to attach the battery adapters. Tighten screws crosswise.

Switch off the camera before installation.

Power Management

When using the PWR connector and an onboard battery adapter simultaneously, the camera's power management system ensures that the power source with the highest voltage level is used. When the voltage level of one power source drops below the level of the other, or a power source is disconnected from the camera, the power management system automatically switches to the other power source, avoiding shutdown of the camera.

The camera supports to prioritize which power source (PWR or BAT) should be used primarily and which one should serve as backup. Available choices are "Highest Voltage" (default), "PWR (power in)", or "BAT (on-board battery)".

5.3 Viewfinder Connection


The camera is equipped with two custom CoaXPress viewfinder connectors, one located at the camera front (labelled VF 1) and one on the camera rear (right side, labelled VF 2).

The Multi Viewfinder MVF-2 is connected to the camera using a custom CoaXPress cable. The cable center pin and shield transport power, video, audio and data and the CoaXPress interface allows for hot plugging the viewfinder. Since the VF connectors have no key, the viewfinder cable can be connected in any orientation.

6 Basic Operation

6.1 Switching On and Off



The *POWER* button is located at the rear of the camera. The button's background light is illuminated when the supplied power is in the valid range.

Switching On the Camera


▶ Press the POWER button.

The camera starts booting. During the boot process, the ARRI logo is shown in the flip-out monitor of the MVF-2 (if connected) and the side display. While the camera is booting up, the *POWER* button's boot status LED is flashing blue. As soon as the camera has finished the boot process, the boot status LED turns to solid blue.

Switching Off the Camera

▶ Press and hold the *POWER* button until the camera has switched off.

6.2 Menu Operation



- ▶ Press the MENU / BACK button (1) on the MVF-2 to access the camera menu.
- ► Rotate the *JOGWHEEL* (3) or the *USER WHEEL* (5) to scroll up or down to select the desired menu entry:

Entries with a ">" at the end navigate to a submenu. To navigate to a submenu press the JOGWHEEL center or the SET button (4). To return to a higher menu level press the MENU / BACK button.

Entries with a value allow for direct editing. To edit a value press the *JOGWHEEL* center or *SET* button, then rotate the *JOGWHEEL* or *USER WHEEL* to select the desired value. Press the *JOGWHEEL* center or *SET* button to confirm the change or press *CANCEL* to discard.

Entries with a check box allow for direct activation/deactivation. Press the *JOGWHEEL* center or *SET* button to activate/deactivate the setting.

▶ To leave the menu press the HOME / LIVE button (2).

The JOGWHEEL and the USER WHEEL + SET button provide identical functionality.

Cleaning and Repair 30

7 Cleaning and Repair

7.1 Cleaning Instructions

ADVICE



Improper Cleaning Procedure

Risk of damage of surfaces.

- ▶ Only use the cleaning agents specified in this chapter.
- ▶ Do not use any strong or aggressive cleaning detergents like Methanol, Acetone, Benzine or acids. These chemicals may dissolve the paint on the camera body, damage highly polished surfaces and damage the optical coating of lenses.
- Do not moisten connectors when cleaning the camera.
- ▶ During cleaning of the camera, always make sure that the protective cap is on the lens mount.
- Avoid touching optical surfaces.
- Avoid wiping dry optical surfaces with a dry cloth, especially if the surfaces are not clean.
- Avoid wiping optical surfaces without air blow dusting first. If particles or optical surfaces are electrostatically charged, it may improve dusting efficiency to use deionized air.
- ▶ Compressed air should not be used on the camera body and electronic accessories.

ATTENTION

Refer to the lens manufacturer's instructions for cleaning lenses.

Recommended Cleaning Agents

- Water
- Glass Cleaner
- Isopropyl Alcohol

Cleaning Information Camera Body

Area	Cleaning Procedure
Camera body	Clean the camera body, mechanical and electronic accessories with a soft, lint free cleaning cloth and some water or glass cleaner. Only when really necessary, e.g. to remove residues of camera tape, isopropyl alcohol should be used.
Narrow spaces and gaps	Use a manual air blower, cotton swabs or a soft brush to remove dust particles from narrow spaces and gaps.
Ventilation channel	Clean the ventilation channel using a vacuum cleaner at low level.

Cleaning Information Sensor Cover Glass

If the sensor cover glass has been contaminated by particles or smear, special optical cleaning kits should be used for dirt removal under very high care. If the contamination cannot be removed, the camera should be taken to an ARRI Service center for cleaning.

- Remove the recording medium.
- Disconnect all cables and power sources from the camera.
- Always store the camera in a suitable case.

- Do not store the camera in places where it may be subject to extreme temperatures, direct sunlight, high humidity, severe vibration, dust or strong magnetic fields.
